"Client", and James J. Lapierre doing business as Firehouse Entertainment, hereinafter referred to as the "DJ".

### WITNESSETH

NOW THEREFORE, in consideration of the promises and the agreements herein contained and intending to be legally bound hereby, the Parties do agree as follows:

1. The Client hereby hires the DJ to provide professional DJ service for the Client at the above-mentioned venue for the contracted amount.
2. The DJ hereby agrees to render his professional services which consist primarily of providing musical entertainment by means of a recorded music format and master of ceremonies /announcement services.
3. Jim Lapierre will DJ your event. In the extreme case Jim Lapierre cannot perform due to illness or injury, a comparable DJ will be arranged. If a substitute DJ cannot be found, the DJ's only liability will be limited to the refunding of any monies paid by the Client.
4. Liability of the DJ shall not exceed the deposit.
5. The individual or organization represented below assumes all responsibility for physical damage to the mobile equipment caused by the Client, guest or third parties. Electronic malfunctions remain the responsibility of the DJ.
6. The DJ is not responsible for any accidents or injuries caused by the music, lighting or any DJ equipment owned by the DJ.
7. This agreement guarantees that the DJ will be ready to perform at the start time of the engagement. No guarantee is made as to the DJ's time of arrival; however the DJ requests that they be permitted 90 minutes before the engagement and 60 minutes after the engagement for setup and takedown.

INITIALS

\_\_\_\_\_A minimum non-refundable deposit of 50% is required to secure the function date and is applied to the total amount contracted. No date is reserved until a deposit is received with this contract filled out and signed. **The balance is to be paid ON THE DAY /NIGHT OF the scheduled event.**

\_\_\_\_\_The Client will pay the DJ at a rate of \_\_\_\_\_dollars per hour (also due on the date of the event) if the parties agree to extend the entertainment beyond the contracted end time.

\_\_\_\_\_The Client pays for total amount as stated in contract, not less than the contracted amount should the event end before the contracted end time or be cancelled without required notice as stated below.

\_\_\_\_\_If the Client needs to cancel, a twenty-four (24) hour notice prior to event must be given. Failure to do so will result in the Client paying the balance of the contract due.

\_\_\_\_\_The Client must provide a 6 or 8 foot banquet table with at least one 20 amp-power supply and high speed internet access (via ethernet or wireless). Additionally, if setup is outdoors, client is to provide a covered area.
